**LWV Upper Mississippi River Region**, or UMRR (pronounced “Ummer”), is an interleague organization (ILO) focused on water quality. UMRR is made up of 60 local Leagues in the states of Iowa, Illinois, Minnesota, and Wisconsin representing over 7,000 local League members in this region. Our geographic area is the Upper Mississippi River basin – that part of the Upper Mississippi basin upstream of the river’s confluence with the Ohio at the south edge of Illinois to its headwaters in Itasca County, MN. **UMRR annual meeting is May 21, 2022, via ZOOM.** Business meeting starts at 9:00 am and preregistration is required; available on the website. The program, “**Does it take an Act of Congress to protect the Mississippi?**” begins at 10:30 am. Panelists include: Alicia Vasto, Iowa Environmental Council; Brandt Thorington, Mississippi River Cities and Town Initiative; Lara Bryant, Natural Resources Defense Council; and Kristen Wallace, Upper Mississippi River Basin Association.

**UMRR BOARD MEETINGS:** The Board meets six times a year on the first Monday of even numbered months via ZOOM.

**UMRR EDUCATIONAL PROGRAMS:** As part of each Board meeting, we hold an educational session that focuses on a specific topic of concern in the watershed. Our education sessions are aimed at educating league members on the issues within the UMRR watershed to learn what we can do on an individual, community, regional and national level to protect and improve water quality in the Mississippi River. These educational sessions **are free and open to the public** and recorded videos are shared and posted on our website. We encourage local Leagues to utilize these session recordings as part of their educational programming.

**Educational sessions during 2021-22:**

- Dubuque, IA, efforts to protect and improve water quality (August 2)
- PFAS (fire-suppression chemicals) contaminating water in Wisconsin (October 4)
- How Federal farm policy created the Gulf of Mexico Dead Zone (December 6)
- En-Roads Climate Change Simulator (February 7)
- Ground water sustainability in Minnesota (April 7)
